- Submit ads as Adobe Acrobat PDF (press quality). Please convert all RGB and CMYK image files to GRAYSCALE. No spot colors; please convert to grayscale equivalents. Ensure all fonts are embedded in the PDF. We will accept native file formats for the following programs on a Macintosh platform: Adobe Illustrator (up to CS3), Adobe InDesign (up to CS3) and Adobe Photoshop (up to CS3).
- Also acceptable are EPS files with converted fonts, Adobe Illustrator up to CS3 or Adobe Photoshop up to CS3 or earlier. Please convert all fonts used to paths, outlines, or rasterize text layer to avoid font problems. Please include all placed EPS and TIFF images with file.
- For line art files, 1,200 dpi is required. For photos and grayscale TIFFs, 300 dpi is required.
